(AMENDMENT) (NO. 2) REGULATIONS, 2024
(SL 63 of 2024)**

In exercise of the powers conferred by section 69 of the Limited Liability Companies Act (2023 Revision), the Cabinet makes the following Regulations —

Citation and commencement

1. (1) These Regulations may be cited as the Limited Liability Companies (Fees) (Amendment) (No. 2) Regulations, 2024.
- (2) These Regulations come into force immediately after the coming into force of the *Limited Liability Companies (Amendment and Validation) Act, 2024*.

Amendment of the Schedule to the Limited Liability Companies (Fees) Regulations (2020 Revision) - fees

2. The *Limited Liability Companies (Fees) Regulations (2020 Revision)* are amended in the Schedule —
 - (a) by deleting items Nos. 11 and 12 and substituting the following items and fees —

“No.	Description	Fee CI\$
11	Express fee under section 59B(1)(a) or (b)	\$500
12	Express fee under section 59B(1)(c)	\$500”;



- (b) in items Nos. 13, 14 and 15, by deleting the words “to section 69(c)” and substituting the words “to section 59A”, respectively;
- (c) by deleting item No. 16 and substituting the following item and fee —

“No.”	Description	Fee CI\$
16	Fee pursuant to section 59A for the issue of any certificate (other than a certificate specified in this Schedule)	\$150”;

and

- (d) by inserting after item No. 20, the following items and fees —

“No.”	Description	Fee CI\$
21	Refund processing fee	\$50
22	Pre-clearance fee for a merger under section 46	\$400
23	Fee for a merger under section 46, 50 or 51	\$1,000 per constituent entity
24	Fee for correction of error made by a company on its filed documents	\$125
25	Fee for a customised certificate requested by a company	\$500
26	Fee for a customised letter requested by a company	\$500
27	Express fee with respect to a merger under section 46, 50 or 51	\$500 per constituent entity
28	Express fee with respect to deregistration under section 55	\$500
29	Express fee with respect to reregistration under section 56	\$500
30	Express fee for a customised certificate requested by a company	\$150
31	Express fee for a customised letter requested by a company	\$150”.
